POSITIVE. The result of the pregnancy test was clear: positive.

“Oh no, no this can’t happen! I want babies, but I can’t do this now. I’ve signed contracts, I’m committed to this career path. This can’t be happening.”

Madison was grieved and she shared the news of her pregnancy with her fiancé, Chad. *“Whatever you want to do, I’ll support you.”* She knew he was trying to be loving, but those words offered little comfort as Maddie grieved the timing of her circumstances. She adored the idea of motherhood and raising a family with this man she loved so deeply. But now was not the time, she knew what she would have to do: they would terminate the pregnancy and move on with life. Plans would continue full steam ahead.

Madison visited Your Options Medical and shared with her Advocate that she had had some time to process the news and the decision she had to make. *“I’m feeling more at peace with our decision to have to end the pregnancy now.”* But, the ultrasound changed everything. Hot tears began to well in her eyes and streamed down Maddie’s cheeks. *“I’m just not so sure. The ultrasound made my pregnancy so real. I feel so confused. I’m happy and sad all at once. I need to go talk with Chad.”*

During a follow up call, Madison shared that Chad had lit up at just the first glimpse of the ultrasound picture. *“The ultrasound made it so real, seeing the baby move and watching the heartbeat made all the difference!”* A few short months later, Madison and Chad welcomed their sweet little girl, Hazel, into the world.

A taxpayer funded media campaign against Massachusetts pregnancy centers, designed to tarnish our reputation and dissuade women from seeking our services, was launched in June, 2024 by the governor, attorney-general and the commissioner of the Department of Public Health.

Sadly, the campaign to discredit pregnancy centers coupled with the consumer advisory warning issued in 2022 was effective: fewer women received services at a pregnancy center than in previous years. And in direct correlation, the latest statistics available from 2023 indicate the number of abortions in Massachusetts rose by 37% - and we expect these numbers to be even higher when the 2024 statistics are released. Massachusetts is now known as an “abortion sanctuary state” as elected officials encourage women to travel here from other states because of our abortion friendly laws.

For those of us who have defended the life of the preborn for years, we can so easily grow discouraged. But in his letter to the Galatians, Paul encourages to “not grow weary of doing good, for in due season we will reap, if we do not give up.”

We have no intention of giving up and I believe neither do you.

As we enter into 2025, we are committed to continuing our outreach to mothers at risk for abortion, to explore options for new centers, train more nurses and advocates and pursue justice in the public arena.

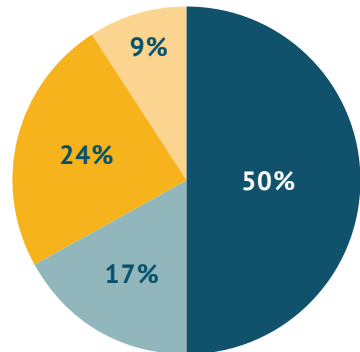
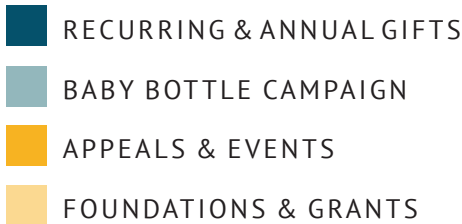
FINANCES

Receiving 50% of our income from recurring and annual gifts allows us to meet the financial obligations of operating four physical locations and a mobile clinic and remain mission focused. The response of our donors to direct appeals along with participation in baby bottle campaigns indicates broad base support for the mission. Our staff remains the most important component of the ministry and because of the generosity of our supporters, we were able to hire two new nurses in 2024. Both are currently being trained in sonography which allows us to provide more ultrasounds to pregnant women making a pregnancy decision. Thank you for your continued, generous support.
